MCPA’S BOARD OF DIRECTORS HAS ULTIMATE SAY OVER VENDOR APPROVAL

- All spaces must be set up and all vehicles must be removed from the main park area by 10am Saturday
- Bring your own tables, chairs, tents/shades, electrical cords, lights, etc.
- Spaces are approximately 10’ X 10’ on some uneven ground, some under oak trees
- APPROVED Food vendors are individually responsible for contacting and obtaining applicable licenses from the Lake County Health Department (707) 994-2257. They usually come Saturday to inspect all food booths.
- Spaces are limited and awarded on a first come, first served basis
- The Park reserves the right to sales of all beverages, hot dogs, hamburgers for itself (this is a Park fundraiser). There is no charge to come and enjoy Middletown Days.
- The Park does not allow the sale of KNIVES, CAP GUNS, NOISE MAKERS, STINK BOMBS, SILLY STRING OR anything else the Board of Directors deems dangerous or that might scare horses. If a vendor is caught selling one of these items the vendor will be asked to leave immediately and no refund will be given.
- If you bring lights, you can sell during the dance Saturday night. Each vendor is responsible for his/her belongings at their space. There is no overnight security. It is suggested that all valuables be removed overnight.
- THERE IS NO OVERNIGHT CAMPING ALLOWED AT THE PARK
